## Oldest Air Conditioner Replacement Contest Terms and Conditions

### **Eligibility:**

- The competition is open to legal residents within 30 miles of Abbotsford, WI (54405).
- Participants must be the owners of the residential property where the air conditioner is installed.
- Employees of Red Barn Service, persons living in the same household, its affiliates, subsidiaries, advertising, promotion, fulfillment agencies, and legal advisors are not eligible to participate in the competition.

### **Competition Period:**

- The competition begins March 19, 2026, at 4:00 PM CST and ends May 30th, 2026, at 11:59 PM CST. Entries submitted before or after this period will not be considered.

### **How to Enter:**

- To enter, participants must submit a photo of their air conditioner, along with the model and serial number to verify age, via website submission only.
- All entries must include the participant's full name, address, contact information, and a statement of consent to verify the age and condition of the air conditioner by Red Barn Service.

### **Minimum Equipment Age:**

- Only air conditioners that are at least 15 years old as of the date of entry are eligible for the competition.

### **Prize:**

- Free Red Barn Service 13 SEER American Standard air conditioner or equivalent unit.
- The winner will receive a free air conditioner replacement, including installation by Red Barn Service.
- All participants who submit a valid entry will receive a free AC Inspection service for their air conditioner, Limit to one AC Inspection per household.

### **Selection of Winner:**

- The winner will be determined by Red Barn Service based on the oldest air conditioner submitted.
- The decision by Red Barn Service will be final and binding.

### **Notification of Winner:**

- The winner will be contacted directly by Red Barn Service via the contact information provided in the entry form.
- If the winner cannot be contacted or does not claim the prize within 14 days of notification, Red Barn Service reserves the right to withdraw the prize from the winner and pick a replacement winner.
